Tenet Shareholders Elect Ten Directors

DALLAS – May 10, 2007 – Tenet Healthcare Corporation (NYSE: THC) announced today the results of voting at its Annual Meeting of Shareholders, held on May 10, 2007 in Dallas, Texas.

A total of 433,213,233 shares were voted in person or by proxy, representing 91.57 percent of total shares outstanding as of the record date of March 15, 2007. Ten directors were elected to one-year terms on the company's board. In addition, shareholders approved the amended Annual Incentive Plan and ratified the selection of Deloitte & Touche LLP as the company's independent registered public accountants for 2007.
